AN ORDINANCE TO AMEND PART II, GENERAL LEGISLATION, CHAPTER 226, PARKING, OF THE REVISED GENERAL ORDINANCES OF THE CITY OF GARFIELD

BE IT ORDAINED, by the Governing Body of the City of Garfield that Part II, General Legislation, Chapter 226, Parking, is hereby amended as follows:

Section 1. The current text of City Ordinance that Part II, General Legislation, Chapter 226, Parking, is hereby amended to create the following article:

Article X- Safety Sticks

Section 2. The current text of City Ordinance that Part II, General Legislation, Chapter 226, Parking, Article X, is hereby amended to create the following article:

§226-47 Purpose.

The City has deployed Safety Sticks technology at various locations to monitor parking activity and enforce parking regulations in certain no-parking zones such as fire hydrants, bus stops, crosswalks, and loading zones.

Section 3. The current text of City Ordinance that Part II, General Legislation, Chapter 226, Parking, Article X, is hereby amended to create the following article:

§ 226-48 Violations and penalties.

Any person who violates the provisions of this section of the Code shall be punished by a fine in the amount of \$60. A separate offense shall be deemed committed on each day the vehicle remains parked in violation of this article. No court appearance is necessary.

Section 4. The current text of City Ordinance that Part II, General Legislation, Chapter 226, Parking, Article X, is hereby amended to create the following article:

§ 226-49 Removal of vehicles.

Any unoccupied vehicle parked or standing in violation of this article shall be deemed a nuisance and a menace to the safe and proper regulation of traffic, and any peace officer may provide for the removal of such vehicle. The owner shall pay the reasonable costs of the removal and storage, which may result from such removal, before regaining possession of the vehicle.

Section 5. The current text of City Ordinance that Part II, General Legislation, Chapter 226, Parking, Article X, is hereby amended to create the following article:

§ 226-50 Enforcement.

Enforcement of this Article and further rules and regulations as may be promulgated from time to time shall be under the jurisdiction the Police Department of the City of Garfield or the Parking Enforcement Officers of the City of Garfield.

Section 6. Any article, chapter, section, paragraph, subsection, clause, or other provision of the Code inconsistent with the provisions of this ordinance is hereby repealed to the extent of such inconsistency.

Section 7. In case, for any reason, any portion or provision of this Ordinance shall be held to be unconstitutional or invalid, the same shall not affect any other portion or provision of this Ordinance, except so far as the portion or provision so declared unconstitutional or invalid shall be severed from the remainder or any portion thereof.

BE IT ORDAINED, by the Governing Body of the City of Garfield that Part II, General Legislation, Chapter 226, Parking, Article VI, Resident Parking Program, Section 226-28, Resident parking program, is hereby amended as follows:

Section 1. The current text of City Ordinance, Part II, General Legislation, Chapter 226, Parking, Article VI, Resident Parking Program, Section 226-28, Resident parking program, Subsection B(2), Rules and regulations, is hereby amended as follows:

Proof of residency of the owner of a vehicle must be presented when applying for a permit. The following are required proof of residency:

- a. a copy of a valid New Jersey driver's license reflecting the vehicle owner's residency within the City of Garfield;
- b. a copy of a valid New Jersey motor vehicle registration for which the permit is sought showing the vehicle owner's address in the City of Garfield;
- c. a current car insurance statement showing the vehicle's owner's address in the City of Garfield; and
- d. one additional item reflecting the vehicle owner's residency, such as a utility bill or current bank statement. A post office box number will not be deemed proof of residency in order to receive a resident parking permit.
- e. In addition to the proof of residency described herein, all applicants for resident parking permits shall be required to produce a "dwelling certificate" in accordance with the provisions of City Ordinance No. 2213.¹¹ *[1]Editor's Note: See Ch. 128, Dwelling Certificates.*

Section 2. All other provisions of this Chapter, Article, and Section endure and shall remain in full force and effect;

Section 3. Any article, chapter, section, paragraph, subsection, clause, or other provision of the Code inconsistent with the provisions of this ordinance is hereby repealed to the extent of such inconsistency.

BE IT ORDAINED, by the Governing Body of the City of Garfield, that Part II, General Legislation, Chapter 260, Sanitation, is hereby amended as follows:

SECTION 1. The current text of City Ordinance, Part II, General Legislation, Chapter 260, Sanitation, Article I, Definitions and Rules of Construction, Subsection 260-2 Definitions, is hereby amended as follows:

§260-2 Small Animals

Includes rabbits, cats, dogs, guinea pigs, chickens, excluding roosters, and any other small animal kept or raised for private food consumption or for hobby

SECTION 2. The current text of City Ordinance, Part II, General Legislation, Chapter 260, Sanitation, Article III, Keeping of small animals, Subsection 260-15, Size of hutch or coop is hereby amended as follows:

§ 260-15 Size of hutch or coop.

It shall be unlawful for any person to keep any Small Animals on the exterior of any premises in the City of Garfield unless kept in a hutch or coop having a size of greater than eight square feet of floor space and being greater than two feet in height unless special permission of the Health Officer is obtained for the use of hutches or coops of a smaller size. Each hutch or coop shall be dry and adequately ventilated and shall be cleaned daily and rebedded with fresh straw, leaves or other absorbent material. No hutch or coop for the keeping of Small Animals shall be closer than twenty-five feet from any property line.

SECTION 3. Any article, chapter, section, paragraph, subsection, clause, or other provision of the Code inconsistent with the provisions of this ordinance is hereby repealed to the extent of such inconsistency.

In case, for any reason, any portion or provision of this Ordinance shall be held to be unconstitutional or invalid, the same shall not affect any other portion or provision of this Ordinance, except so far as the portion or provision so declared unconstitutional or invalid shall be severed from the remainder or any portion thereof.

AN ORDINANCE TO AMEND PART II, GENERAL LEGISLATION, CHAPTER 48, POLICE DEPARTMENT, ARTICLE I, ESTABLISHMENT AND ORGANIZATION, OF THE REVISED GENERAL ORDINANCES OF THE CITY OF GARFIELD

WHEREAS, Chapter 48, Police Department, Article I, Establishment and Organization, Section 1, Department Established; personnel, sets forth the table of organization/number and types of positions within the police department; and

WHEREAS, the City of Garfield desires to modify these policies to increase the number of civilian records clerks to meet the current demands of the Police Department; and

NOW, THEREFORE, BE IT ORDAINED, by the Governing Body of the City of Garfield, that Part II, General Legislation, Chapter 48, Police Department, Article I, Establishment and Organization, Section 1, Department Established; personnel, is hereby amended as follows:

Section 1. The current text of City Ordinance, Part II, General Legislation, Chapter 48, Police Department, Article I, Establishment and Organization, Section 1, Department Established; personnel, is hereby amended as follows (deletions marked by “---“ and additions in **bold**):

A. A Police Department is hereby established in and for the City of Garfield to consist of such relative rank and number of officers in each rank as is hereinafter set forth:

(1) Table of organization/number and types of positions within the police department:

- (a) Chief of Police: One.
- (b) Deputy Chief: Up to one.
- (c) Captain of Police: Up to four.
- (d) Lieutenant of Police: Up to eight.
- (e) Sergeant of Police: Up to 12.
- (f) Police officers: Up to 60.
- (g) Civilian employees as follows:
 - [1] Dispatchers: Up to 10.
 - [2] Part-time dispatchers: Up to 15.
 - [3] Records clerks: ~~Three~~ **Four**.
 - [4] Traffic maintenance personnel: Two.
 - [5] E.M.S. personnel: 15.
 - [6] Crossing guards: Up to 36.
 - [7] Special police officers: Four.

B. The number of officers and the number of civilian employees in each rank or position set forth above shall be the maximum number in each of those ranks or positions. The actual number of officers or civilian employees in each individual position shall be determined on an as-needed basis and as designated by the City Manager, Chief of Police and governing body.

Section 2. Any article, chapter, section, paragraph, subsection, clause, or other provision of the Code inconsistent with the provisions of this ordinance is hereby repealed to the extent of such inconsistency.

Section 3. In case, for any reason, any portion or provision of this Ordinance shall be held to be unconstitutional or invalid, the same shall not affect any other portion or provision of this Ordinance, except so far as the portion or provision so declared unconstitutional or invalid shall be severed from the remainder or any portion thereof.
