**AN ORDINANCE TO AMEND §226 OF THE CITY CODE OF THE CITY OF GARFIELD, ENTITLED, “PARKING” SPECIFICALLY AMENDING §226-23 ENTITLED “RESTRICTED STREETS”**

**WHEREAS** the Governing Body of Garfield believes it is in the best interest of the City of Garfield to Amend §226 of the City Code of the City of Garfield to restrict the parking on the portion of Harrison Avenue between Charles Street and Frederick Street;

**BE IT ORDAINED** by the Mayor and City Council of Garfield, County of Bergen, State of New Jersey, as follows:

**SECTION 1.** §226-23 of the City Code of the City of Garfield, entitled ‘**Restricted Streets**’, is hereby amended to add the following:

**§ 226-23. Restricted Streets**

Pursuant to the provisions of this article and based upon the findings of the Chief of Police, or his designee, made in accordance therewith, no person who does not hold a parking permit issued in accordance with the terms of this article shall park any vehicle on the following described streets or portions thereof in the City of Garfield between the hours and on the days indicated:

Harrison Avenue	Both	Monday-Friday 7a.m.–7p.m.	Charles Street to Frederick Street

**SECTION 2.** All ordinances of the City of Garfield, which are inconsistent with the provisions of this ordinance, are hereby repealed to the extent of such inconsistency.

**SECTION 3.** If any section, subsection, clause or phrase of this ordinance is for any reason held to be unconstitutional or invalid by any court or competent jurisdiction, such decision shall not affect the remaining portion of this ordinance.

**SECTION 4.** All other provisions of §226 of the Code of the City of Garfield are not further amended and remain in full force and effect.

**SECTION 5.** The ordinance shall take effect immediately upon final passage.

**WHEREAS**, statutory authority provides that the Mayor and Council for the City of Garfield by Ordinance may provide contribution to the City Fire Department; and

**WHEREAS**, the annual clothing allowance serves an integral role in providing comfort and safety to members of the Fire Department as well as to the citizens of the City of Garfield;

**WHEREAS**, the Mayor and Council finds it is in the best interest of the City to increase the contribution to the clothing allowance for current members.

**NOW, THEREFORE, BE IT ORDAINED** by the Governing Body of the City of Garfield, that Part I, Administrative Legislation, Chapter 23, Fire Department, Article III, Clothing Allowance, is hereby repealed and replaced as follows:

Section 1. The current text of City Ordinance, Part I, Administrative Legislation, Chapter 23, Fire Department, Article III, Clothing Allowance, is hereby repealed and replaced as follows:

**§ 23-21: Determination of allowance.**

- A.** On or before May 1 of each year, the Captain of each fire company shall submit a bona fide list of all members of his respective company who were active during the twelve-month period ending December 31 of the preceding year. Such list shall include the number of months of service for each fireman. For these purposes, any part of the month shall be considered service for the entire month.
- B.** Each member named on the Captain's list shall be paid an annual clothing allowance on or before June 30, as follows:

Second Assistant Chief	\$1,525
Third Assistant Chief	\$1,450

- C.** For members serving less than 12 months, a prorated amount shall be paid based upon their months in service.

Section 2. All other provisions of Chapter 23 are hereby ratified and remains in full force and effect;

Section 3. Any other chapter of the City Code that conflicts with this ordinance is hereby repealed to the extent of the conflict;

Section 4. If any section, subsection, clause or phrase of this ordinance is for any reason held to be unconstitutional or invalid by any court or competent jurisdiction, such decision shall not affect the remaining portion of this ordinance.

**WHEREAS**, statutory authority provides that the Mayor and Council for the City of Garfield by Ordinance may provide contribution to the City Fire Department; and

**WHEREAS**, the annual clothing allowance serves an integral role in providing comfort and safety to members of the Fire Department as well as to the citizens of the City of Garfield;

**WHEREAS**, the Mayor and Council finds it is in the best interest of the City to increase the contribution to the clothing allowance for current members;

**NOW, THEREFORE, BE IT ORDAINED** by the Governing Body of the City of Garfield, that Part I, Administrative Legislation, Chapter 23, Fire Department, Article II, Allowances for Exempt Firemen, is hereby amended as follows:

Section 1. The current text of City Ordinance, Part I, Administrative Legislation, Chapter 23, Fire Department, Article II, Allowances for Exempt Firemen, is hereby amended to include the following:

**§ 23-16: Firemen serving 21 or more years.**

Each member of the several fire companies in the City of Garfield who shall have become exempt from further duty subsequent to January 1, 1971, and who shall have served as an active volunteer fireman doing public fire duty with a minimum attendance to such duty of not less than 60% and who shall have continuously performed such services for not less than 21 years, shall, upon the faithful completion of such period of service, thereafter be entitled to receive the annual clothing allowance equal to that of an active fireman that was established upon their retirement and/or exemption and not be subject to the increases, if any, established thereafter.

**§ 23-17: Firemen serving at least 14 years.**

Each member of the several fire companies in the City of Garfield who shall have become exempt from further duty subsequent to January 1, 1971, and who shall have served as an active volunteer fireman doing public fire duty with a minimum attendance to such duty of not less than 60% and who shall have continuously performed such services for not less than 14 years but not more than 21 years shall, upon the faithful completion of such period of service, thereafter be entitled to receive 30% of the annual clothing allowance that was established upon their retirement and/or exemption and not be subject to the increases, if any, established thereafter.

**§ 23-18: Firemen serving at least 7 years.**

Each member of the several fire companies in the City of Garfield who shall have become exempt from further duty subsequent to January 1, 1971, and who shall have served as an active volunteer fireman doing public fire duty with a minimum attendance to such duty of not less than 60% and who shall have continuously performed such services for not less than seven (7) years but not more than 14 years shall, upon the faithful completion of such period of service, thereafter be entitled to receive 15% of the annual clothing allowance that was established upon their retirement and/or exemption and not be subject to the increases, if any, established thereafter.

**ORDINANCE OF THE CITY OF GARFIELD, COUNTY OF BERGEN, NEW JERSEY, ADOPTING A REDEVELOPMENT PLAN FOR THE PROPERTY COMMONLY KNOWN AS 28 WALNUT STREET AT BLOCK 119.03, LOT 36 AS SHOWN ON THE TAX MAP OF THE CITY OF GARFIELD, AND AMENDING ORDINANCE § 341-16 BY ADDING THE WALNUT STREET REDEVELOPMENT ZONE-THE “RESIDENTIAL 2-1R” ZONING DISTRICT WITH CERTAIN ADDITIONAL RESTRICTIONS AND ALLOWANCES AT § 341-16 C TO THE R-2 ZONING DISTRICT PURSUANT TO N.J.S.A. 40A:12A-1 ET SEQ., THE LOCAL REDEVELOPMENT AND HOUSING LAW**

**WHEREAS**, the Local Redevelopment and Housing Law, *N.J.S.A. 40A:12A-1, et seq.*, as amended (the “Redevelopment Law”), authorizes municipalities to determine whether certain parcels of land in the municipality constitute areas in need of rehabilitation or redevelopment; and

**WHEREAS**, in accordance with the Redevelopment Law, the City Council of (“Council”) of the City of Garfield (the “City”) on September 14, 2021, adopted Resolution #21-302 designating the proposed Redevelopment Plan area, Block 119.03, Lot 36 (as may have been or may be merged with each other) as an area in need of redevelopment for non-condemnation purposes pursuant to the Redevelopment Law (“Property”), and

**WHEREAS**, to facilitate the proper development of the Property and effectuate the redevelopment of same, the City had caused the preparation of a Redevelopment Plan for the Property pursuant to the authority granted under the Redevelopment Law; and

**WHEREAS**, due to the continued stagnation of the properties the City Council finds it necessary to implement the 2023 Walnut Street Redevelopment Plan to allow for a site plan application to be completed and submitted to the Garfield Planning Board (“Planning Board”) for the Planning Board’s review and approval, said site plan application shall be submitted by any potential redeveloper having contractual ownership interest(s) in the Property; and

**WHEREAS**, pursuant to the Redevelopment Law, the Planning Board of the City must review the Redevelopment Plan and transmit its comments relating to the Redevelopment Plan to the City in accordance with the provisions of N.J.S.A. 40A:12A-7 of the Redevelopment Law; and

**WHEREAS**, upon receipt of the Planning Board’s comments relating to the Redevelopment Plan, the City Council believes that the adoption of the 2023 Walnut Street Redevelopment Plan is in the best interest of the City and will further the health, safety and welfare of its citizens and will fulfill the objective of the state Development and Redevelopment Plan by enhancing commuter access to the nearby Plauderville Train Station;

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and City Council of the City of Garfield as follows:

**Section 1.** The foregoing recitals are incorporated herein as if set forth in full.

**Section 2.** The Redevelopment Plan, first dated January 31, 2023 as revised as of June 18, 2023, prepared by Benecke Economics and attached hereto as Exhibit A and made a part hereof, is hereby adopted pursuant to the terms of N.J.S.A. 40A:12A-7 of the Redevelopment Law.

**Section 3.** The City Council hereby finds and determines that pursuant to Section 5 of the Redevelopment Plan that the “Property having a minimum of thirty thousand square feet of land” shall be subject to the Land Use and Bulk Regulations of the Redevelopment Plan. Accordingly, a site plan must be filed by the designated redeveloper with the Garfield Planning Board for the Redevelopment Plan, and any interpretations thereto shall be referred to the redevelopment consultant, to be effectuated.

**Section 5.** If any part of this Ordinance shall be deemed invalid, such parts shall be severed and the invalidity thereby shall not affect the remaining parts of this Ordinance.

**Section 6.** A copy of this Ordinance and the Redevelopment Plan shall be available for public inspection at the office of the City Clerk during regular business hours.

**Section 7.** This Ordinance shall be in full force and effect from and after its adoption and any publication as may be required by law.
