WHEREAS, changes have been recommended by the Recreation Director and supported by the City Manager, as noted in the memo attached hereto; and

WHEREAS, all other elements of the current schedule are to remain the same, if not addressed in the attached memo;

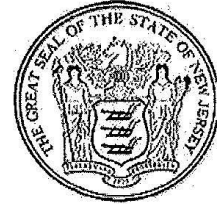

Birthday Rental Recreation Center Fee:

Per hour plus small insurance fee \$115.00
