ORDINANCE NO.: 3159**

AN ORDINANCE AMENDING CHAPTER 226, ARTICLE V OF THE CODE OF THE CITY OF GARFIELD ENTITLED “PERMIT PARKING ON RESIDENTIAL STREETS” TO PROVIDE FOR LIMITED WAIVERS OF INELIGIBILITY FOR CERTAIN MULTIUNIT PROPERTIES

WHEREAS, the City of Garfield has previously adopted regulations governing resident parking permits on residential streets pursuant to Chapter 226, Article V of the City Code; and

WHEREAS, § 226-36 currently provides that residents of multiunit properties consisting of five (5) or more rental or condominium units approved for construction after January 1, 2020, shall not be eligible for resident parking permits issued under this chapter; and

WHEREAS, the Mayor and Council recognize that certain condominium and townhouse developments may have different parking configurations, ownership structures, and resident needs than traditional apartment buildings; and

WHEREAS, the Mayor and Council desire to provide limited authority for the City Manager to review and grant waivers from the ineligibility provision under appropriate circumstances while preserving the intent of the ordinance;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the City of Garfield, County of Bergen, State of New Jersey, as follows:

SECTION 1. Amendment to Chapter 226, Article V, § 226-36

Chapter 226, Article V, § 226-36 of the Code of the City of Garfield is hereby amended by adding the following subsection:

§ 226-36(C) Waiver for Certain Condominium and Townhouse Developments

Notwithstanding the provisions of this section, the City Manager, or their designee, may grant a waiver from the ineligibility provisions contained herein for residents of condominium or townhouse developments consisting of five (5) or more units, provided that such development is not a traditional apartment building or rental complex, upon a determination that such waiver is warranted based upon the specific circumstances of the property.

In determining whether to grant a waiver, the City Manager may consider, but shall not be limited to, the following factors:

1. The ownership structure and nature of the development;
2. Whether individual units are privately owned and occupied;
3. The availability and configuration of off-street parking spaces;
4. The impact of resident parking on surrounding streets;
5. The number of units within the development;
6. The age and design of the development;
7. Any other factors deemed relevant by the City Manager in determining whether the waiver would be consistent with the purpose and intent of this chapter.

Any waiver granted pursuant to this subsection shall be issued in writing and may include reasonable conditions or limitations deemed necessary by the City Manager to protect public health, safety, and the orderly use of public parking.

The City Manager shall have the authority to revoke any waiver upon a finding that the conditions upon which the waiver was granted no longer exist or that the waiver creates an adverse impact on surrounding residents or municipal parking operations.

SECTION 2. Severability

If any section, subsection, clause, or provision of this Ordinance shall be adjudged invalid, such adjudication shall not affect the validity of the remaining portions of this Ordinance.

SECTION 3. Effective Date

This Ordinance shall take effect upon final passage and publication as required by law.

BOND ORDINANCE TO AUTHORIZE THE UNDERTAKING OF WATER SYSTEM IMPROVEMENTS ALONG BANTA AVENUE (PHASE I) AND PLAUDERVILLE AVENUE IN, BY AND FOR THE WATER UTILITY OF THE CITY OF GARFIELD, IN THE COUNTY OF BERGEN, STATE OF NEW JERSEY, TO APPROPRIATE THE SUM OF \$1,400,000 TO PAY THE COST THEREOF, TO AUTHORIZE THE ISSUANCE OF BONDS TO FINANCE SUCH APPROPRIATION AND TO PROVIDE FOR THE ISSUANCE OF BOND ANTICIPATION NOTES IN ANTICIPATION OF THE ISSUANCE OF SUCH BONDS

BE IT ORDAINED by the City Council of the City of Garfield, in the County of Bergen, State of New Jersey, as follows:

Section 1. The City of Garfield, in the County of Bergen, State of New Jersey (the "City") is hereby authorized to undertake water system improvements along (i) Banta Avenue (Phase I), consisting of replacement of lead water service lines, and (ii) Plauderville Avenue, consisting of replacement of lead water service lines and water mains in, by and for the Water Utility of the City. Said improvements shall include all work, materials and appurtenances necessary and suitable therefor.

Section 2. The sum of \$1,400,000 is hereby appropriated to the payment of the cost of making the improvements described in Section 1 hereof (hereinafter referred to as "purpose"). Said appropriation shall be met from the proceeds of the sale of the bonds authorized by this ordinance. No down payment is required for this bond ordinance pursuant to the provisions of N.J.S.A. 40A:2-11(c) and 40A:2-7(h). It is anticipated that a grant in the amount of \$944,000 from the United States Environmental Protection Agency shall be received by the City to finance the cost of the improvements described in Section 1 hereof. Said grant funds shall be applied as set forth in Section 10 hereof. Said improvements shall be made as general improvements and no part of the cost thereof shall be assessed against property specially benefited.

Section 3. It is hereby determined and stated that (1) said purpose is not a current expense of said City, and (2) it is necessary to finance said purpose by the issuance of obligations of said City pursuant to the Local Bond Law (Chapter 2 of Title 40A of the New Jersey Statutes Annotated, as amended; the "Local Bond Law"), and (3) the estimated cost of said purpose is \$1,400,000, and (4) the estimated maximum amount of bonds or notes necessary to be issued for said purpose is \$1,400,000, and (5) the cost of such purpose, as hereinbefore stated, includes the

aggregate amount of \$202,000 which is estimated to be necessary to finance the cost of such purpose, including architect's fees, accounting, engineering and inspection costs, legal expenses and other expenses, including interest on such obligations to the extent permitted by Section 20 of the Local Bond Law.

Section 4. It is hereby determined and stated that the Water Utility would have been self-liquidating, as defined in Section 47(a) of the Local Bond Law, during the fiscal year beginning January 1, 2025, had there been included in the interest and debt redemption charges for such year an amount equal to interest for one year at the rate of four and one half percentum (4½%) per annum on said bonds or notes, and the amount of the first installment of serial bonds legally issuable to finance such purpose plus an amount for charges as aforesaid with respect to all bonds and notes authorized but not issued for such Water Utility.

Section 5. To finance said purpose, bonds of said City of an aggregate principal amount not exceeding \$1,400,000 are hereby authorized to be issued pursuant to the Local Bond Law. Said bonds shall bear interest at a rate per annum as may be hereafter determined within the limitations prescribed by law. All matters with respect to said bonds not determined by this ordinance shall be determined by resolutions to be hereafter adopted.

Section 6. To finance said purpose, bond anticipation notes of said City of an aggregate principal amount not exceeding \$1,400,000 are hereby authorized to be issued pursuant to the Local Bond Law in anticipation of the issuance of said bonds. In the event that bonds are issued pursuant to this ordinance, the aggregate amount of notes hereby authorized to be issued shall be reduced by an amount equal to the principal amount of the bonds so issued. If the aggregate amount of outstanding bonds and notes issued pursuant to this ordinance shall at any time exceed the sum first mentioned in this section, the moneys raised by the issuance of said bonds shall, to not less than the amount of such excess, be applied to the payment of such notes then outstanding.

Section 7. Each bond anticipation note issued pursuant to this ordinance shall be dated on or about the date of its issuance and shall be payable not more than one year from its date, shall bear interest at a rate per annum as may be hereafter determined within the limitations prescribed by law and may be renewed from time to time pursuant to and within limitations prescribed by the Local Bond Law. Each of said bond anticipation notes shall be signed by the

Mayor and by a financial officer and shall be under the seal of said City and attested by the City Clerk or Deputy City Clerk. Said officers are hereby authorized to execute said notes in such form as they may adopt in conformity with law. The power to determine any matters with respect to said notes not determined by this ordinance and also the power to sell said notes, is hereby delegated to the Chief Financial Officer who is hereby authorized to sell said notes either at one time or from time to time in the manner provided by law.

Section 8. It is hereby determined and declared that the period of usefulness of said purpose, according to its reasonable life, is a period of thirty years computed from the date of said bonds.

Section 9. It is hereby determined and stated that the Supplemental Debt Statement required by the Local Bond Law has been duly made and filed in the office of the City Clerk of said City, and that such statement so filed shows that the gross debt of said City, as defined in Section 43 of the Local Bond Law, is increased by this ordinance by \$1,400,000, but said \$1,400,000 shall be deducted from gross debt pursuant to Section 44(c) of the Local Bond Law and that the issuance of the bonds and notes authorized by this ordinance is permitted by an exception to the debt limitations prescribed by the Local Bond Law as provided in Sections 47(a) and 7(h) of the Local Bond Law.

Section 10. Any funds received from private parties, the County of Bergen, the State of New Jersey or any of their agencies or any funds received from the United States of America or any of its agencies in aid of such purpose shall be applied to the payment of the cost of such purpose, or, if bond anticipation notes have been issued, to the payment of the bond anticipation notes, and the amount of bonds authorized for such purpose shall be reduced accordingly.

Section 11. The capital budget is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency therewith and the resolutions promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, is on file with the City Clerk and is available for public inspection.

Section 12. The City intends to issue the bonds or notes to finance the cost of the improvements described in Section 1 of this bond ordinance. If the City incurs such costs prior to the issuance of the bonds or notes, the City hereby states its reasonable expectation to

reimburse itself for such expenditures with the proceeds of such bonds or notes in the maximum principal amount of bonds or notes authorized by this bond ordinance.

Section 13. The full faith and credit of the City are hereby pledged to the punctual payment of the principal of and the interest on the obligations authorized by this ordinance. Said obligations shall be direct, unlimited and general obligations of the City, and the City shall levy ad valorem taxes upon all the taxable real property within the City for the payment of the principal of and interest on such bonds and notes, without limitation as to rate or amount.

Section 14. This ordinance shall take effect twenty days after the first publication thereof after final passage.
